MEETING NOTES

These notes taken at monthly meetings are extracted from the Pamlico Amateur Radio Society weekly newsletter, the PARSgram. Although they are not formal minutes, they constitute a record of those meetings.

PAMLICO AMATEUR RADIO SOCIETY (PARS) JAN 20, 2016 MEETING NOTES (Thanks to Randy K4WRD, Mike K4HPS, and others who took notes at the meeting for this PARSgram.)

* Twenty-five PARS members and guests attended the breakfast meeting chaired by President Bill Olah, KR4LO.

* Wally Wallace, KK4ASP, presented the treasurer's report.

* Mike Hurm, K4HPS, our Pamlico County ARES EC, reported 4 ARES sessions in November for 14.5 volunteer man-hours. Mike also provided a summary of National ARES activities. Nets, events and volunteer man-hours were all significantly up in 2015. With only 33 of 71 ARES Sections reporting, volunteer man-hours totaled 232,093, a big donation of time and effort. Given a dollar value of \$19 per hour, that number--"Volunteer Value"--equals \$4,409,767. He also noted that a new satellite will be placed in geosynchronous orbit in 2016. It will be available for emergency communications.

* There was no VHF report or Solar Summary this month.

* Greg, KM4DZM, advised that on Saturday, March 19, there will be a "Color Run" in Aurora, a potential health safety service for the club.

* Bill Michne is coordinating club participation in the NC QSO Party--Sunday the 28th from 10am to 8pm. The intent is to have those without HF capability participating at "host" ham shacks open for group participation. Should make for great fun! Bill reported that In 2015 there were 325 logs entered and Pamlico stood 13th out of 100 counties, so let's make Pamlico one of the top ones again! [See details below.]

* Next Fox hunt is being planned for the end of March. A directional antenna with attenuator is required and members can get help with both. Email Randy, K4WRD, for info on the attenuators (<u>randyd@centurylink.net</u>) We will have a build day at Bill Olah's for those needing to build the "measuring tape antenna". Let Randy know if you need materials for your antenna. You should procure your own attenuator first if possible.

* Dave Bacon's suggestions for meeting presentations were offered for

discussion:

1, Everyone's most cherished QSL cards (bring them to the meeting) and maybe a story to go with it.

2, Talks on RTTY, JT65, PSK31 etc from club members who are into different modes.

3, Talk on logging programs and why member chose the program they did.

4, Talk about the HF rig that members chose and what they like about it.

5, After the business meeting a field trip to different hams shack to have a show and tell.

* Regarding ongoing business, President Olah again advised that the Bi-Laws are under revision to add the information needed for Federal Tax Exemption as a non-profit organization. Changing annual election to the November meeting is also being considered. Those elected would begin their term in January.

* There was no new business raised by members at the meeting.

* Thirty-five PARS members and guests attended the breakfast meeting chaired by President Bill Olah, KR4LO.

* Wally Wallace, KK4ASP, presented the treasurer's report.

* Mike Hurm, K4HPS, our Pamlico County ARES EC, reported 4 ARES sessions in January for 13.8 volunteer man-hours.

* According to AI4WL, there has been little VHF activity recently, only weather enhanced tropo on 2M and a few E layer skip Q's reported on 6M. For DX this month, look for the DXpedition to Heard Island to be active starting on 20 March.

* Bill Michne, coordinating club participation in the NC QSO Party, advised several stations will be hosting PARS members including his station, WM3X, Glenn's, N4LV, Bill Olah's. KR4LO, and Jim's AI4WL. N4LV and KR4LO will focus on RTTY, AI4WL on weak signal (SSB) VHF. The intent is to have those without the equipment and those wanting contesting experience a station to use and help if desired.

* Next Fox hunt is being planned for Saturday, March 19. A directional antenna with attenuator will be helpful and members can get help with both. Email Randy, K4WRD, for info on the attenuators (<u>randyd@centurylink.net</u>) Let Randy know if you need materials for your antenna.

* Dave Bacon KD2T reported reaching the 8 band DXCC level. Mike Hurm, K4HPS, passed the exam for Extra Class.

* There will be an equipment auction following the March meeting before the SKYWARN course. SKYWARN training is being provided by John Cole from the Newport National Weather Service.

* Tom KI4NSP reminded that all are welcome to check into the SKYWARN practice net on the Oriental or other local repeaters at 2100 local Tuesday evenings. He emphasized that SKYWARN not gives emergency warning to those monitoring, but in turn provides the NWS eye-witness ground truth reports on severe conditions in the reporting area.
* The Kingston Hamfest for 2016 will be on Saturday, April 23. A VE
Testing Session will be offered as well as SKYWARN training.
* Following the business meeting, several members talked about memorable
QSOs and the (QSL) cards or documents that confirmed them.

PAMLICO AMATEUR RADIO SOCIETY (PARS) MAR 26, 2016 MEETING NOTES

* Twenty-eight PARS members and guests attended the breakfast meeting chaired by President Bill Olay, KR4LO.

* Bill presented the treasurer's report on behalf of Wally Wallace, KK4ASP.

* There was no ARES report. Bill asked for volunteers to back-up Mike Harm, K4HPS, our Pamlico County ARES EC, who conducts the Pamlico Emergency Net on Wednesday nights. A script will be provided.

* According to AI4WL, there has been some VHF activity recently--several contacts reported from the mid-West into Eastern Europe and the Med on 6 Meter CW. He also reported that the Heard Island stations now active with over 8,000 contacts made in the first few hours of operation. Glenn, N4LV reported he had logged the 20M CW station early through heavy QRM.

* Jim cautioned everyone to be wary of email from alleged hams identified only by call sign. He had just received one from a silent key. The text contains only a short greeting--the same as in the email subject line-- followed by a URL likely to produce a virus or worse.

* At the urging of the President, Bill Michne, WM3X, described how he helped a local ham report his house on fire. Just happening to be up late with the Oriental repeater on, he heard Mike, KM4COD, call for help. His phone was out and he had smoke. Bill called Pamlico 911 which then immediately switched him to Carteret 911. The Stacy Fire Station quickly responded. Due to the rapid response, the fire was contained to the attic and damage was not severe. Congratulations and thanks went to Bill.

* The Fox Hunt on Mar 19 went well according to Randy, K4WRD. The challenge may have been too easy with Wally, KK4ASP finding the fox only 35 minutes after the 0930 start, quickly followed by Tom, W1TGB. Others found the fox shortly thereafter. Randy promises a tougher course next time.

* A talk about Ham Radio as used by mariners was given by Tom Finta, K8TF last Sunday to about 25 folks at the Oriental History Museum. In the last of a series of presentations related to navigation before GPS, Tom talked about the services provided then and now by and for amateur radio. The talk was well received.

* Bill O. conducted an auction on boxes of vintage vacuum tubes, test equipment and a FT-101 and VFO. All proceeds from the items donated by Mike Hurm went to the club treasury.

* A SKYWARN Basic Course conducted by John Cole of the Newport NWS office followed the PARS meeting. About 20 PARS members and others participated.

* According to AI4WL, with E Skip openings occurring, VHF activity has increased on 6 Meters over the last few days, mostly in the afternoons and evenings.

* Tom Corwin, KI4NSP, advised that a new package has been produced by the Pamlico Rescue Squad, an updated version of the "Card of Life' distributed several years ago by Carl Baxley, KJ4CFG. Stuck on front of the refrigerator, the user provided medical data provides vital information for first responders.

* Although there was interest expressed in participating in the 2016 Field Day, no one stepped up to organize the effort. Bill invited interested members to attend the May PARS planning meeting 0900 on Saturday, May 21 at Brantley's.

* Sam/Dave KD2T reported receiving his certificate for working 1000 "countries" in the ARRL Challenge award program.

* Following the business meeting, Ed Wafford, WD4EDW gave an overview of the HF Digital Modes to an interested audience. It was well received. (PARSgram 20160502)

PAMLICO AMATEUR RADIO SOCIETY (PARS) May 28, 2016 MEETING NOTES

* Twenty-nine PARS members and guests attended the breakfast meeting chaired by President Bill Olay, KR4LO.

* Bill presented the treasurer's report on behalf of Wally Wallace, KK4ASP. Updated club rosters were provided.

* Mike Hurm, K4HPS, our Pamlico County ARES EC, reported 3 Pamlico Emergency Nets in May for 5.42 man-hours. He noted that the annual Hurricane Center Station Test started at 9am this morning and runs until 5pm. A Simulated Emergency Test (SET) is scheduled for Wednesday night in place of the regular Pamlico Emergency Net practice. It will focus on simplex operation on 146.55 MHz after a net call on the Oriental repeater.

* According to AI4WL, we are finally seeing more 6 Meter E Skip openings from Pamlico County. Single hop distances of 700 to 1100 miles were obtained into the Midwest last Tuesday morning. Locally, the NC 6 Meter

net on Saturday mornings is still being called at 7am-8:30 Eastern on 50.200 MHz. local by the NCS in Zebulon. This net has been a regular on Saturdays for over 15 years.

* Bill, WM3X, representing an ad-hoc planning group, proposed a low key approach for PARS members to participate in this year's Field Day Avoiding the challenges of set up and operation under hot, humid and often stormy weather conditions, members can operate one or more "host" stations at times convenient to them. They will have an opportunity to learn about and operate a variety of equipment in modes of their choosing. Stations will have SSB, RTTY, CW, and digital capability, at least one will also focus on the VHF bands when they are open. The approach was well received. Charlie Overcash suggested PARS continue the annual Field Day dinner. More information will be in the June PARSgrams.

* In discussion, Bill Olah determined there was interest in another Fox Hunt. Randy Davis offered to look at a 2 stage Hunt with strong and weak signal foxes.

* After the business meeting, Bill opened a roundtable discussion on antennas. Bill Michne described his "new" 43' vertical, Bill Olah his horizontal loop, Gary N3CZ his "T Top Vertical". Pros and cons of various kinds of wire for radiators and radials were raised. (PARSgram 2016-05-30)

* Thirty-three PARS members, visitors and guests attended the breakfast meeting chaired by VP Randy Davis, K4WRD, at Brantleys' Village Restaurant. Our long distance attendee award went to Torrey Neill KA4TMN, our past member who was visiting from Riverside, CA.

* There was no treasurer's report this month. Wally separately advised two members joined recently, Al Webb KB1N and Eric Baxter N1LDG.

* Mike Hurm, K4HPS, our Pamlico County ARES EC, reported there were 4 Pamlico Emergency Nets in October for 9.5 man-hours. Hurricane Matthew operations involved 336 manhours over the weekend of October 8-9.

* In the VHF report, I reported that although the 6 Meter band seems quiet for "DX", there is activity. Of the 30 contacts reported on DXmaps just before the meeting, 13 were E-skip, 12 meteor scatter, 1 EME, and 3 tropo, and for one propagation was unknown. * With Mike Hurm, K4HPS, being away, there was no Pamlico County ARES EC report this month. * In the VHF report, Jim, AI4WL, reported openings on 6 Meters are increasing in number and size but unpredictable. DXmaps has been showing more contacts of 1200 miles and even double Es hop contacts of 2400 miles. Members were reminded that we now have a PARS 6 Meter net at 8pm local Thursday evenings on 50.200 MHz.

* Five members (Tom KI4NSP, Randy K4WRD, Tommy W4XMT, Bill WM3X, and Jim AI4WL) participated in the ARRL November Sweepstakes yielding a combined PARS claimed score of 16,284. This was our second venture into "Club Contesting".

* Randy outlined some of the major issues discussed at the recent club planning meeting led by President Bill Michne, WM3X.

-- Consider making the Secretary and Treasurer positions separate; fixing some inconsistencies in the By-Laws.

-- Encouraging use of the club Web Site (<u>www.n4prs.org</u>) by increasing content, easing log-in requirements. Gary, NC3Z has populated the "QRZ" page for our club (N4PRS) and initiated a "Facebook" page. Suggestions for content for all are welcomed.

-- Increase our participation in public service activities to obtain more club visibility and support our petition for tax exempt status.

-- Provide even more support to members and new and aspiring hams. Provide hands-on help for first HF stations and antennas, mentoring, "Elmernars", class instruction, and VE sessions.

-- More club activities, e.g., Fox Hunts, Club Contesting, electronics labs (kit building, programming etc), and increasing participation in Field Day

-- Related to increasing participation in club field activities and visibility, Mike Marsh K4NLC, solicited help in finding a travel trailer that the members would convert to a operator friendly communications van. It should be 28-30 ft long, tow-able. The bathroom would remain and air conditioning added. * An auction of several tower grounding components donated by Chris Mele, W4SLH, followed adjournment.

* Thirty-two PARS members, visitors and guests attended the breakfast meeting chaired by President Bill Michne, WM3X, at Brantleys' Village Restaurant.

* Jim, AI4WL provided the treasurer's report on behalf of Wally, KK4ASP. Wally advised that all applications and dues received as of Thursday have been deposited and any members who paid for

ARRL membership via the club have had their applications sent on with payment.

* Mike Hurm, K4HPS, reported 5 ARES nets in November and 4 in December.

* For the propagation report, Jim, AI4WL, advised there has been digital activity (MSK144) reported on 6 Meters and some Es as the Winter season deepens. There is hope for a good VHF contest on the 21st through the 23rd. There were 7 days without sunspots so far this month with many days with noisy reception due to ongoing solar winds.
